## Price List and Conditions for Temporary Telephone Services with Telkom SA

### **RENTAL CHARGE**

Telkom will levy rental for a minimum period of one month, as well as the appropriate installation charge, in respect of each telephone service. Upon the conclusion of the exhibition, the account will be rendered to your business address.

### **PROVISION OF SERVICE**

No telephone service can be guaranteed before the first day on which the exhibition commences. The service will be terminated upon the conclusion of the exhibition. Late applications cannot usually be accommodated.

1. "Temporary service" means the service will be in operation for less than one month.
2. The Installation and Rental fee is **R712.29 per one line** – additional lines more than 1 line charged at **R659.95 per line** (both prices are VAT inclusive). Fees don't include any instruments. For additional month rental on exchange connection fees for 1 month is **R191.84** and 2 months **R383.68** (vat incl.)
3. Fees do **not** include out going calls.
4. Normal call charges within South Africa will apply.
5. At the discretion of Telkom SA, a deposit of **R700.00** per line may also be charged before a service is installed. If customer is not an existing client.
6. Exhibitors that have any outstanding accounts with Telkom must first settle the total amount in full before a service can be provided.
7. **All** local exhibitors are required to forward **copies** of their **Company Registration papers (CC, CO, BK)**, together with a **letter of authorization signed by one of the Company Directors** and a copy of that Director's I/D number if the applicant is not an existing customer.
8. **The aforementioned documents must accompany the application form.**
9. Local exhibitors requiring a line, but who have **never** been registered with Telkom, will be required to pay a Deposit of **R700-00** per line, over and above the installation and rental fees.
10. International exhibitors that are not registered in South Africa will be required to pay a deposit of up to **R5000-00** per line, over and above the installation and rental fees.
11. **All applications must reach Telkom offices at least 14 days before the exhibition begins.**
12. **Late and incomplete applications will not be approved.**
13. The abovementioned information is only applicable to single business lines ie. Fax, Speed point and Telephone lines.
14. ISDN, Data, ADSL and Diginet lines have different conditions and fees. ISDN 2a single line is **R1350.67** Incl. VAT / multiple ISDN 2a @ **R1310.82** Incl. VAT per line. Additional month rental on ISDN 2a lines is for 1 month **R354.29** and 2 months **R708.58**.
15. ISP access - Telkom service provider available after installation of line – call 0800 500 200. Additional cost applicable to this service depend on requirement.
16. Customers requesting ADSL line fastest **R1790.59** (Incl. VAT ) per line - for an additional month rental on ADSL line it will cost **R604.84** per line (vat incl.) and 2 months additional **R1209.68** per line (vat incl.) need to apply at least 1 month in advance. **Please note no modems will be supply with the installation of ADSL lines customer must provide own modem.**
17. All Temporary services will be blocked for international calls. Exhibitors that need to have the line/s unblocked will be requested to sign an indemnity form.
